

Outbreak Background

As of August 27, 2019, 215 possible cases have been reported from 25 states and additional reports of pulmonary illness are under investigation. One patient (in Illinois) with a history of recent e-cigarette use was hospitalized with severe pulmonary disease and subsequently died. Although the etiology of e-cigarette-associated pulmonary disease is undetermined, epidemiologic investigations in affected states are ongoing to better characterize the exposures, demographic, clinical, and laboratory features and behaviors of patients. All patients have reported using e-cigarette products. The exact number is currently unknown, but many patients have reported using e-cigarettes containing cannabinoid products such as THC or CBD.

Legislation



- Childhood Cancer STAR (Survivorship, Treatment, Access, Research) Act
 - Passed in both the Senate and House with strong bipartisan support, signed into law June 2018
 - Research provisions directed toward NIH/NCI focus on childhood, adolescent, and young adult cancer survivorship research, as well as biospecimen collection and biobanking resources
 - Improving Outcomes for Pediatric, Adolescent and Young Adult Cancer Survivors:
 - New RFA in January 2019 that aligns directly with the STAR Act. Awards for the first round of applications will be announced in the coming weeks. Second receipt date January 2020.

Enhancing Biobanking for Childhood Cancers

 NCI convened a biobanking meeting in May 2019 with representatives from across the childhood cancer research and advocacy communities to explore opportunities and challenges in the field. August 2019 supplement to the Children's Oncology Group biobank.
