






A1: Flexible, Integrated Organizational Approach

Expansion of CTWG-created Advisory Committee

- "Clinical Trials Advisory Committee" becomes "Clinical and Translational Advisory Committee" (CTAC to CTAC)
 - Efficient "piggy-backing" on existing structure
 - Value in having a single body oversee entire spectrum of early and late translational research
 - Implementation:
 - Charter change to incorporate Translational Research
 - Additional members with translational research expertise



NCI Internal Organizational Changes

- "Clinical Trials Operating Committee" becomes "Clinical and Translational Research Operating Committee" (CTOC to CTROC)
 - Additional representation from the Division of Cancer Biology
 - Additional representation from the Office of Technology Transfer
 - Agenda to focus on CTWG once/month, TRWG once/month
- "Coordinating Center for Clinical Trials" (CCCT) expands to incorporate mission of the Translational Research Support Office (TRSO).
 - Lynn Matrisian (50% IPA)
 - Additional staff



Action Items

- Modify CTAC Charter to reflect expansion of responsibilities
- Add members to the CTAC to provide additional translational research expertise
- Expand Coordinating Center for Clinical Trials to incorporate Translational Research Support Office functions
