### HOW NCI RECEIVES ITS FUNDING


NCI receives its funding, or appropriation, from Congress as part of the overall federal budget process.

reflects the President's priorities. The President

submits the budget to

Congress, which must pass

appropriations legislation that funds federal agencies.



Nor Froiessional Judgment Authority

The National Cancer Act of 1971 gives the NCI Director special authority to submit an annual professional judgment budget directly to the President for review and delivery to Congress. This budget reflects NCI cancer research priorities and identifies areas of potential investment in cancer research.

Insights on the Federal Budget Process and What it Means for NIH Research

"It is important to note that in instances in which spending levels in the President's Budget for FY2023 are below the appropriations enacted for FY2022, the difference can be explained by the size of the later congressional increase, not the administration's intent to reduce the funding of NIH ICs."

### FY2022 vs. FY2023 (3/15/22) (3/28/22 and 6/23/22)

FY2022 Enacted: NIH: +\$3.24 B (+7.6%)\* NCI: +\$353M (+5.4%)

FY2023 PB Proposed: NIH: +\$16.1 B (+35.3%)\*\* NCI: -\$199M (-2.9%)

#### FY2023 House L-HHS <u>Proposed</u>: NIH: +2.5B (+5.6%)\*\*\* NCI: +\$466M (+6.7%)

\*Includes \$1B for ARPA-H, transferred to NIH 4/15/22

\*\*Includes \$5B proposed for ARPA-H and \$12B for pandemic preparedness \*\*\*Does NOT include ARPA-H (the bill would place those funds within HHS) and does NOT include pandemic preparedness funds (they were proposed in the PB as mandatory funds) <sup>5</sup>

### Congress has a long list of legislative priorities

- Expiring Authorizations ("must pass"):
  - FDA User Fees Reauthorization expires 9/30/22
  - SBIR/STTR expires 9/30/22
  - National Defense Authorization Act (annual)
- Other Priorities (possible action):
  - American Competitiveness Legislation (in conference)
  - ARPA-H Authorization (passed in the House, not yet in the Senate)
  - Pandemic Preparedness
  - Build Back Better
  - COVID Funding

### **Advanced Research Projects Agency for Health (ARPA-H)**

- FY2022 Omnibus appropriated \$1 B, FY2023 Budget Requests \$4 B
  - House L-HHS proposal \$2.75B; House authorizing proposal: \$500 M per year
- HHS Secretary Becerra transferred FY2022 funding to NIH
- Authorizing legislation pending
  - House: Cures 2.0 (DeGette/Upton), ARPH-H Act (Eshoo passed in the House on 6/22)
  - Senate: ARPA-H Act (Murray/Burr)
- Issues Remain Structure, leadership, location, hiring authorities







### FDA User Fees Reauthorization (FY23-27)

- House the Food and Drug Amendments of 2022 (Eshoo/Guthrie/Pallone/McMorris Rodgers) passed in the House on 6/8
  - Provisions to Improve Diversity in Clinical Trials
  - Give Kids a Chance Act
- Senate the HELP Committee approved the Food and Drug Administration Safety and Landmark Advancements (FDASLA) Act (Murray/Burr) on 6/14
- Differences need to be resolved by Congress before the President receives a bill to consider
